ABOUT US

With its key mining contracts with the Government of Ecuador in place, Lundin Gold has now embarked on construction of FDN. The Company is on track to deliver first gold in the last quarter of 2019 and achieve commercial production in the second quarter of 2020. At the same time, the Company is carrying out exploration activities on its other concessions in close proximity to FDN in search of new deposits.

THE ROLE

Reporting directly to the Surface Operations Maintenance Superintendent, the Senior Maintenance planner oversees the contractor's maintenance program of the underground mining fleet. It also includes the planning and execution of maintenance for all surface operation mobile equipment including heavy construction equipment, light vehicles, small tools, concrete, and crushing plants. This program in intended to ensure proper maintenance and repair state of the underground equipment fleet, including the mobile and fixed equipment fleets

RESPONSIBILITIES

- Participate in the pre-qualification of bidders (including capabilities, capacities, and financial status), monitor and track contractors' compliance to Company's Health, Safety and Environmental (HSE), Quality and Finance procedures currently in place.
- Audits the contractor's Underground Maintenance Program to ensure commensurate with industry best practices.
- Ensures contractor's Preventative Maintenance compliance is in accordance with manufacturer's/industry standards. Reports as to compliance and provides analysis of any variances.
- Conducts ongoing, regular reviews to ensure the integrity of the maintenance history database, in acceptable format.
- · Assumes ownership of maintenance history database upon completion of underground mining contract.
- Provides safety oversight in execution of Underground Maintenance Program.
- Reviews contractor's maintenance program to ensure plan includes reasonable resources, training, and supervision a team of skilled and non-skilled workers.
- Ensures maintenance program conforms with manufacturers recommended maintenance and addresses schedules, preventive maintenance equipment repairs, and inspections.
- Audits the planning for major jobs, including the ordering of parts and materials and scheduling of resources.
- Prepares equipment and materials lists for major jobs and ensures that equipment and materials are available when required.
- Investigates all accidents, incidents and near-misses involving the mining fleet, and takes corrective actions for immediate, longer term and permanent remediation;
- Provides recommendations regarding review of contractor's maintenance resources.
- Assess contractor's progress and provide individual instructions, if necessary.
- In collaboration with the Health and Safety Department ensure that the necessary steps are taken to educate employees about the risks and providing appropriate training to reduce or eliminate workplace hazard, including occupational diseases, and protect service employees.

- Develop, administer and communicate department and company policies & procedures.
- Ensure department's compliance with the requirement of Government of Ecuador, shareholders' environmental, health and Safety legislation and company regulations.
